## DESCRIPTION OF THE PROJECT

As part of a partnership agreement with the Ministère de la Culture et des Communications, the Town of Pincourt wishes to showcase local artists and beautify our community. Through the *Passerelle des Arts*, various locations will be developed differently, with a focus on culture.

We are looking for an artist or a collective of artists for the realization of this walking path.

## MANDATE

The mandate is to develop a concept to showcase the visual arts within the development of the *Passerelle des Arts*. The ideation must be in harmony with the proportions of the site that hosts it. In addition to being inspired by the values and vision of the Town of Pincourt, the artist or collective of artists must include a citizen participation dimension to the project.

## TECHNICAL SPECIFICATIONS OF THE PASSERELLE DES ARTS

- The distance is 76 meters.
- The fences are made of several types of materials (wood, steel, and chain link).

The distances shown represent the available area. The work or concept can occupy a smaller area and can be made up of scattered elements on the walls.



## SELECTION CRITERIA

---

- Originality and richness of the concept.
- Integration of citizen participation into the proposal.
- Experience of the artist or collective of artists in outdoor public art.
- Quality of the dossier submitted.
- Credibility and realistic nature of the financial package.
- Respect and coherence of the theme.

The artist or collective of artists must make sure to be available for the vernissage and/or unveiling at the end of the project (date to be determined).

Without limitation, artists residing in the territory of Vaudreuil-Soulanges will be prioritized.

## DESIGN REQUIREMENTS

---

The design requirements for the work are as follows:

The final work must be permanent.

The work must be safe, durable, and easy to maintain.

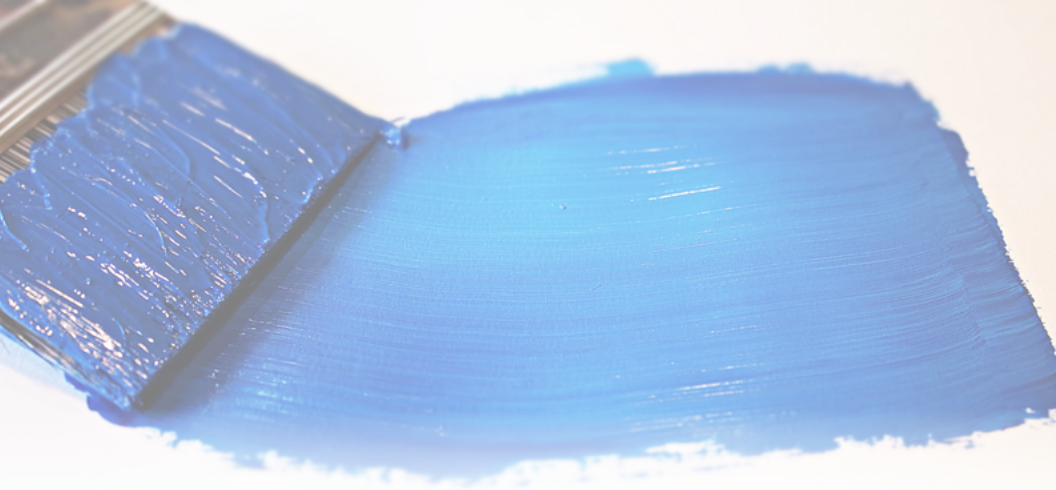

The work may not contain advertising or promotional material.

The work may not contain infringement of intellectual property rights, trademarks, product brands, images of illegal activities.

The work must be made up of entirely original elements. No reproduction, in whole or in part, will be accepted.



## **BUDGET**

The project must be carried out with a budget of \$10,000, taxes included. This includes the fee of the artist or collective of artists, materials and, where applicable, the consultants' fees necessary for the design and realization of the project (work).

## **HOW TO SUBMIT A PROPOSAL**

The dossier must contain the following:

- Up-to-date curriculum vitae or artistic profile.
- A digital image of the proposal (sketch).
- A short description of the proposal (text) also including:
  - Title.
  - Target format.
  - The medium and/or support as well as the techniques.
- A description of participation of the public in the project.

## **DEADLINE**

The project must be submitted:

- No later than June 25, 2023, 11:59 p.m.

Further to the acceptance of the proposal, the artist or collective of artists selected will be contacted, so that he/she/they can finish the proposal in final version with or without modifications, as the case may be.

The kick-off meeting will take place in July 2023. The artist will submit a working method and a timetable.

The inauguration of the *Passerelle des Arts* is scheduled for the end of September 2023.

The artist or collective of artists must be available for the entire duration of the project and for all stages of its development and design.
