Introduction

The purpose of this Town of Pincourt program is to define the regulations and conditions of its grant program for the purchase of sustainable products by the residents of the Town of Pincourt to promote sustainable development.

The Town of Pincourt is looking to support its citizens with grants to help them purchase sustainable products that will cut down on the amount of waste sent to landfill sites and on drinking water consumption and encourage grasscycling and leafcycling. These actions will help reduce greenhouse gas emissions and the costs to collect residual materials.

The provisions of the Municipal Powers Act allow municipalities to intervene in environmental matters and also provide for the possibility of granting financial assistance when deemed appropriate.

The Town of Pincourt Council has therefore decided to create this grant program and earmark a total budget of 5000 \$ every year.

Cloth diapers for babies

Cloth diaper for babies grant program

The cloth diaper grant program to buy or rent washable/reusable diapers aims to reduce the volume of disposable diapers discarded in the garbage and, subsequently, sent to a landfill.

Using cloth diapers for just one child can reduce up to one ton of waste. This volume of waste will take several hundred years to decompose in a landfill.

Eligibility

The following conditions must be met to benefit from this grant program:

- Be a Pincourt resident at the time they purchase the diapers
- Have parental authority over an unborn child or a child under 12 months of age. In the case of an adoption, the adoption must have been finalized within the last 12 months

Grant amount

A maximum of \$100 or 50% of the cost to buy or rent cloth diapers and reusable cloth diapers, per child, will be granted under this municipal grant program. A minimum of 15 cloth diapers must be purchased or rented.

Grant application / criteria

Applicants must apply for a grant in writing, using the form provided by the Town of Pincourt. The application form is included as Schedule 1 to this document.

Shredder blade

Shredder blade grant program

The grant program to buy a shredder blade aims to reduce the amount of green waste produced and to promote grasscycling and leafcycling in the Town of Pincourt.

The use of shredder blades provides lawns with natural fertilizer that improves their quality by promoting disease resistance. Moreover, clippings contain 80% water, which reduces the amount of watering required. Shredder blades that cut the grass finely also speed up its decomposition.

For these reasons, it is advisable for citizens to purchase a shredder blade so that they can change their maintenance habits and adopt green practices.

Eligibility

The permanent residence of the applicant must be within the territory of the Town of Pincourt on the date the grant application is submitted.

Grant amount

A maximum of \$25 or the cost a shredder blade will be granted under this municipal grant program.

The grant is conditional on the shredder blade being a commercially available product specifically designed by the manufacturer for grass and leaf shredding.

Grant request criteria

Applicants must apply for a grant in writing, using the form provided by the Town of Pincourt. The application form is included as Schedule 2 to this document. The following documents must be submitted with the application:

- Proof that the applicant resides in the Town of Pincourt
- The original invoice or receipt and the name of the business where the blade was purchased
- The invoice must specify that a shredder blade was purchased.

The Town of Pincourt encourages its citizens to purchase the shredder blade from a business located in Pincourt.

Low-flush toilet

Low-flush toilet grant program

The Town of Pincourt is offering a grant to replace an old toilet with a new low-flush toilet to reduce drinking water use. A standard toilet uses up to 20 litres per flush. Toilet water accounts for a significant percentage of the water used by citizens every day.

Eligibility

The applicant must be the owner of a residence located in the Town of Pincourt to be eligible for this grant program.

Grant amount

A maximum municipal grant of \$75 for the purchase of a toilet that meets one of the qualifying criteria in the following section.

Grant request criteria

Applicants must apply for a grant in writing, using the form provided by the Town of Pincourt. The application form is included as Schedule 3 to this document.

The specified criteria must be met, and the following documents must be submitted with the application:

- A maximum municipal grant of \$75 per toilet is available for the replacement of a standard toilet for a low-flush toilet. A maximum of two (2) toilets per address are eligible for the program.
- The replaced toilet(s) must be brought to a recognized eco-centre for recycling.
- The toilet must meet one of the following criteria:
 - 1. Maximum flow rate of six litres per flush
 - 2. Dual-flush system
 - 3. WaterSense certified
 - 4. HET certified
- The applicant must provide proof of residence when they submit the completed form.
- Proof of purchase that shows the type of toilet purchased, including details proving that the toilet has the required specifications, and the name and address of the toilet supplier.
- A photo of the old toilet prior to its removal and a photo of the newly installed low-flush toilet must also be submitted with the application.

The Town of Pincourt encourages its citizens to purchase the low-flush toilet from a business located in Pincourt.



Rainwater recovery barrel grant program

To reduce municipal drinking water use, the Town of Pincourt wants to encourage rainwater recovery for flowerbed, vegetable garden and lawn watering.

Eligibility

Applicants must be the owner of a residence located in the Town of Pincourt to be eligible for this grant program.

Grant amount

A maximum municipal grant amount of \$50 will be awarded for the purchase of a rainwater recovery barrel.

Grant request criteria

Applicants must apply for a grant in writing, using the form provided by the Town of Pincourt. The application form is included as Schedule 4 to this document.

The following documents must be submitted with the application:

- Proof that the applicant resides in the Town of Pincourt
- The original invoice or receipt and the name of the business where the rainwater recovery barrel was purchased.

The Town of Pincourt encourages its citizens to purchase the rainwater recovery barrel from a business located in Pincourt.

Riverbank regreening

Riverbank regreening grant program

The Town of Pincourt wants to encourage its citizens to regreen waterfront riverbanks. Regreening riverbanks with a variety of plants restores both their beauty and, above all, their ecological value, while helping to prevent water body contamination and its premature aging.

Revegetation helps stabilize the shoreline, creates a sunscreen that curbs the warming of the water and also acts as a filter.

Eligibility

The applicant must be the owner of a residence located in the Town of Pincourt to be eligible for this grant application. The applicant must be the owner of the waterfront property, which must be located in an isolated single-family dwelling zone.

Grant amount

A maximum of \$300 per property will be awarded for the purchase of plants under the municipal grant.

Grant request criteria

Applicants must apply for a grant in writing, using the form provided by the Town of Pincourt. The application form is included as Schedule 5 to this document. The following documents must be submitted with the application:

- Proof that the applicant resides in the Town of Pincourt and that the land covered by the application belongs to the applicant
- A to-scale plan of the plant layout showing the location of the plants as well as their species and size. This plan must have been prepared by a landscape architecture professional
- A technical quote prepared by a professional in the landscape architecture field detailing the cost of the project, the ground cover plants, planting techniques and mitigation measures that will be used to comply with best waterfront practices.
- Any other document the Town may need to analyze the application.
- The chosen plants must be native and adapted to the site. They must be chosen from species reco gnized for their specific waterfront-friendly features.
- The Town of Pincourt recommends purchasing plants from a business located in the MRC of Vaudreuil-Soulanges.
- The original invoice(s) or receipt(s) and the name of the business where the plants were purchased.
- Once the planting work is done, the regreened waterfront land must feature three levels of vegeta tion: trees, shrubs and herbaceous plants.
- An expert mandated by the Town will verify the work's compliance to complete the process before the grant is issued to the applicant.

Purchase of a tree at the birth or adoption of a child

Grant

program for the purchase of a tree at the birth or adoption of a child

Upon the birth or adoption of a child, the Town of Pincourt will award a maximum of \$75 for the planting of a tree on the applicant's property.

Elibility

Applicants must be the owner of a building located in the Town of Pincourt to be eligible for this grant program.

The applicant must provide proof from a competent authority demonstrating parental authority and showing that the child is less than 12 months old or that the adoption was finalized less than 12 months from the grant application date.

Grant request criteria

Applicants must submit their application for a grant in writing using the form provided by the Town of Pincourt. The following documents must be submitted with the application:

- Proof of residence
- Proof that the applicant has parental authority
- Proof that the baby is less than 12 months old in the case of a birth or proof that the adoption was formalized within the last 12 months
- Original invoice indicating the species of the tree
- Photo showing the tree planted on the property

The Town of Pincourt recommends purchasing trees from a business located in the MRC of Vaudreuil-Soulanges.

Sustainable Personal Care Products (SPCP)

Grant

program for the purchase of a sustainable personal care product

Personal hygiene products are important source of polluan composed since they tion. are mainly of plastics from the oil industry. The problem is largely the decomposition time. Sanitary pads take an average of 500 to 800 years to decompose.

Elibility criteria

To be eligible for the Program of financial assistance for the purchase of durable personal care products, you must :

- Reside in the Municipality of Pincourt
- Complete the application form, attach supporting documents and send the application to the Municipality.
- The claim must be submitted within six (6) months of the purchase of the durable personal care products.
- Purchase the product in a store. Receipts from individuals for the sale of durable personal care products are not accepted.
- Respect the following list of eligible products:
- menstrual cups
- menstrual panties
- washable sanitary pads;
- underwear with incontinence protection;
- reusable incontinence products.

A maximum reimbursement of \$100 per person may be accepted. If durable personal hygiene products are purchased on multiple dates, all invoices must be submitted at the same time.

There are now several alternatives to gas-powered gardening tools on the market. The Town of Pincourt wishes to encourage the purchase of this type of product from our local merchants.

Elibility criteria

To be eligible for the Financial Assistance Program for the purchase of battery/electric/manual gardening tools, you must:

- Reside in the Municipality of Pincourt
- Complete the application form, attach supporting documents and send the application to the Municipality.

The application for reimbursement must be submitted within six (6) months of the purchase of the gardening tools.

- Purchase the product in a local store (in the MRC of Vaudreuil-Soulanges).
- Respect the following list of eligible products:
- Trimmers;
- Hedge trimmers;
- lawnmowers.

The town pays up to 75\$ of the purchase price of an electric or battery lawnmower, and up to 50\$ of the purchase price of a manual lawnmower or hedge trimmer, electric, battery or manual trimmer.

Environmental grant program

Five thousand dollars is the total amount earmarked for this municipal environmental grant program for the year. Grants will be awarded on a first-come, first-served basis.

Schedule 1

CLOTH DIAPERS FOR BABIES GRANT PROGRAM

The grant program for cloth diapers for babies is intended for families who reside in the Town of Pincourt.

As part of its Sustainable Development Policy, the Town of Pincourt encourages the use of cloth diapers to reduce the amount of waste sent to landfills. Per child, the use of cloth diapers reduces up to one ton of waste that may take several hundred years to decompose.

A maximum grant of \$100, or 50% of the purchase or rental cost per family or child, is available to citizens who participate in the cloth diaper program.

GRANT PROGRAM ELIGIBILITY REQUIREMENTS

- Be a resident of the Town of Pincourt
- Be a parent of a child under the age of one (1) at the time the application is submitted
- Purchase new diapers or contract a cloth diaper rental service
- The minimum number of cloth diapers purchased or rented is set at 15.

SUPPORTING DOCUMENTS REQUIRED TO APPLY FOR A GRANT

A maximum grant of \$300 per property is available to citizens who own waterfront property in the Town of Pincourt.
