

**POLL OF NOVEMBER 5, 2017**

**PUBLIC NOTICE OF THE REVISION OF THE MUNICIPAL LIST OF ELECTORS**

**PUBLIC NOTICE** is hereby given by the Returning Officer that:

1. The municipal list of electors has been deposited in the office of the municipality on October 3, 2017. **The list will now be revised for district 2, 3, 4 and 5 only.**
2. The requirements to be met to be an elector and be entitled to have your name entered on the list of electors are the following:

Every person who, on November 5, 2017, is of full age and on **September 1, 2017:**

- is a Canadian Citizen;
- is not under curatorship;
- is not convicted of an offence that is a corrupt electoral practice;

and

- is either:
  - domiciled in the territory of the municipality and, since at least six (6) months, in Quebec;
  - since at least twelve (12) months, either :
    - ⇒ **sole owner of an immovable** in the municipality, who is not otherwise domiciled on the territory of the municipality and who has transmitted to the Returning Officer a written application for entry on the list of electors;
    - ⇒ **sole occupant of a business establishment** in the municipality, who is not owner of an immovable elsewhere in the municipality, who is not domiciled on the territory of the municipality and who has transmitted to the Returning Officer a written application for entry on the list of electors;

**NOTE:** The sole owner of several immovables or the sole occupant of several business establishments in the municipality must be entered on the list at the address of the immovable or business establishment having the highest property value.

- ⇒ **co-owners of an immovable or co-occupants of a business establishment** in the municipality, who has been designated, from among themselves, by means of a power of attorney signed by a majority of the co-owners or co-occupants who are electors on September 1, 2017.

Cannot be designated to be entered on the list of electors the co-owner who is already an elector as a domiciled person, sole owner of an immovable or sole occupant of a business establishment. Cannot be designated to be entered on the list of electors the co-occupant who is already an elector as a domiciled person, sole owner of an immovable, sole occupant of a business establishment or co-owner of an immovable.

3. In the case of an application for entry of a person domiciled on the territory of the municipality, the person requesting this entry must give the preceding address of the domicile of the person for whom the application is requested, and must present two (2) documents one of which must mention the name and date of birth and the other the name and address of the domicile of the person for whom the application for entry is requested.
4. The list of electors may be examined and applications for entry (domiciled electors only), striking off and correction must be presented to the Board of Revision at the following place, dates and hours:
